In furtherance to our intimation letter dated December 22, 2025, regarding receipt of Demand Order from the Office of Deputy Commissioner, Lucknow, Uttar Pradesh under Section 73 of IGST/CGST/SGST Act, 2017 and rules framed thereunder for the financial year 2021-22. The Company had filed rectification application for the aforesaid order.

After due consideration, the authority through their Rectification Order dated March 19, 2026, vide has reduced the amount to **Rs. 0 (incl. penalty)** against original demand of Rs. 89,63,361/-.
